Amendment No. 1

Proposed by: International Board of Trustees

Amend the WBCCI Constitution, Article IX, Title: Board of Trustees, Section 5 (page 4) by deleting the entire Section and insert a new Section 5 as follows:

"There shall be three (3) meetings of the Board of Trustees each year. The President may elect to hold one such meeting prior to or during the International Club Rally at which the Board ends its term and the first meeting at which the Board begins its term during or following the International Rally. The third will be held during the first calendar quarter at the discretion of the President. The President may call special meetings of the Board of Trustees upon giving the members thereof ten (10) days prior written notice of the time and place of any such special meeting."

Report of the WBCCI Constitution and Bylaws Committee

As directed by the WBCCI Constitution, Article XVI, Section 3, this report is submitted by the Constitution and Bylaws Committee.

The Board of Trustees (IBT) at its mid-winter meeting in Sarasota FL voted to send this amendment to the Delegates meeting at the 2018 international Rally in Salem OR. The intent of the amendment is to allow the current or newly elected President the flexibility to hold the IBT meeting(s) before, during or after the International Rally. The current Constitutional language requires the President to hold the IBT meeting ending his/her term prior to the International Rally. The newly elected President and officers have normally held their first IBT meeting after the Rally. Holding these meeting(s) during the Rally allows maximum participation of the membership in the governing process of the club. It can also address access and cost issues associated with holding the IBT meetings at the rally site.

The Committee in reviewing this amendment sees the value of increasing the flexibility of the outgoing or newly elected President in determining the date of the business meetings of the club as well as increasing the opportunity for participation by the membership.

The Committee strongly recommends that this motion to amend the Constitution be approved.

There were no nominations from the floor.

WBCCI Constitution, Article XI (12), Sec.5, states, "If there be only one candidate for an office, a roll call vote may be dispensed with by Unanimous Consent of the Delegates." The Chair recognized Bob Caldwell, Delegate from Alberta Saskatchewan Unit 120. Objection was voiced towards all but the Nominating Committee candidates.

A roll call vote for the position of International President, Jim Cocke (James M. Cocke) nominee, was taken. Results were: Yes 5671, No 11 and Abstentions 3. President Girard announced that Jim Cocke (James M. Cocke) was elected International President for 2017-2018; congratulations were extended to Jim.

The Chair recognized Bob Caldwell, Delegate from Alberta Saskatchewan Unit 120, who stated that he felt he could meet the intent of his members by modifying his objection by withdrawing the International 1st and 3rd VPs, International Recording Secretary and International Treasurer from his request for a roll call vote.

President Girard recognized Joe Perryman, Delegates' Meeting Supervisor, who stated that an alternate Delegate for Shenandoah Valley of Virginia Unit was available; the delegate was seated.

A roll call vote for the position of International 2nd Vice-President, Mona Heath nominee, was taken. Results were: Yes 5637, No 16 and Abstentions 5. President Girard announced that Mona Heath was elected International 2nd Vice President for 2017-2018; congratulations were extended to Mona.

If there is no objection, a roll call vote will be dispensed with for the offices of International 1st and 3rd Vice Presidents, International Recording Secretary and International Treasurer. Hearing no objection, the roll call was dispensed with and:

Barry Bell was elected International 1st Vice President for 2017-2018. Congratulations Barry.

Andrew Selking was elected International 3rd Vice President for 2017-2018. Congratulations Andy.

Barb Selking was elected International Recording Secretary for 2017-2018. Congratulations Barb.

Bill (JJ) Johnjulio (William P. Johnjulio) was elected International Treasurer for 2017-2018. Congratulations JJ.

Article XII (12), Sec.7 of the Constitution states: "If there are only two (2) candidates for the two (2) Nominating Committee positions, a roll call vote may be dispensed with by unanimous consent of the Delegates....Committee. (6/30/08)"

Hearing no objection, the two Nominated Candidates were elected. Congratulations Jane and Karen.
