The President may call special meetings of the Board of Trustees upon giving the members thereof ten (10) days prior written notice of the time and place of any such special meeting.

#### **Article IX, Sec.5** will then read:

There shall be three (3) meetings of the Board of Trustees each year. The President may elect to hold one such meeting prior to or during the International Club Rally at which the Board ends its term and the first meeting at which the Board begins its term during or following the International Rally. The third will be held during the first calendar quarter at the discretion of the President. The President may call special meetings of the Board of Trustees upon giving the members thereof ten (10) days prior written notice of the time and place of any such special meeting.

**Rationale:** Current practice is to hold the IBT meeting before the start of the International Rally and before the membership attending the rally are on site. This deprives the membership of the opportunity to take part in the deliberations of issues brought before the IBT. This change allows the membership attending the rally to participate in those deliberations.




