- Provided employment for many men in the community.
- Taught young boys good work habits.
- Provided fresh, pasteurized milk, three meals a day for Minnesota's 10,635 orphaned, dependent and neglected children.
- Cream was sold at Gilt-Edge Creamery, was exchanged for butter, which to help feed the large population of children and staff.
- Fresh milk and butter, along with homemade bread from the School's bakery, provided a healthy, stable diet for the children.

When the School's population reached 500 children (+100 staff) in the 1930's - The State School milked 50 to 60 Holstein cows daily.
