Many good things are in the works. First I will bring you up to speed on the motions.

Manitoba.

Motion 1 - Unit Flag for the Illinois Lincoln Land Unit was approved.

Motion 2 - Was withdrawn and the Blue Beret Chairperson was asked to add unit numbers to Blue Book and to do an alphabetical listing in the Directory of Units with Unit and Region numbers after making it easier for Unit members to be aware of their Unit number.

Motion 3 - The Vintage Airstream Club has a Unit in each Region and asked that they would be allowed to host a 'buddy rally' in each Region once a year. This will be on a 2 year trial and is not to conflict with a Unit, Region, International, or Special Event Rally. This motion was adopted.

Motion 4 - Was to delete the information about the Unit Past President's, First Lady, and First Mate pins in the Blue Book which had been discontinued as a budget item. Cost of the pins \$35.00 plus. Adopted.

Motion 4A - Reinstated the giving of Unit Past President's, First Lady, and First Mate pins but at a cost of less than \$2.00. Design was approved.

Motion 5 - Remove information on Telephone Credit Cards from the Blue Book. Adopted.
 Motion 6 - Adding 'and intra-clubs' to the By-Laws Article VI, Section 2 (page 15). It will now read: In accordance with US Internal Revenue Service requirements, every 5 years all units and intra-clubs shall prepare a Constitution and ByLaws (Incorporated units may use their incorporation

TALL SHIPS FESTIVAL RALLY UPDATE - Airstreamers get your reservations in for the Tall Ships Festival ASAP. Send your rally fee to Carolyn Grandstrand. Florida State Rally

T his concerns the discontinuation of the second largest rally in WBCCI, the Florida State Rally normally held in February in Sarasota. This was the 40th year for the rally with 335 rigs in attendance.

The Florida Board of Governors (management agency of the Florida State Rally) this week voted to:

- 1. Discontinue the present Florida State Rally in 2014 and future years. (They did not terminate it so that if in the future, the Units in Florida may re-establish a State Rally)
- 2. Discontinue the Florida Board of Governors after all finances are completed. (This will require some time as the rally had lost their non-profit tax exemption through WBCCI due to non-filing for three years. This put them in the status of being a profit organization with IRS)
- 3. By their Bylaws (previously approved in 2003), they have determined to distribute all remaining monies (after this years expenses and IRS) to the existing Florida Units on the basis of voting membership based on the Headquarters listing (normally done on June 1 for the Delegates Meeting)

All of this resulted in:

- A. No one willing to step forward to assume the position of Rally Director.
- B. Problems with IRS (and they do exist when activities do not properly file).
- C. An impossible situation in that WBCCI could not possibly take over the management of this rally based on work load of our management people and the extremely short time period available to sign a contract for the grounds. (Normally done before the end of the rally for next year and the lineup of other groups that would be glad to have our ground times).
- D. Most of Florida is in Region 3 (7 of 8 Units), and this Region could not take the responsibility of managing this Rally as it is a major event that takes in itself most of a year to plan and organize. This is in addition to being the largest region in number of units.

This rally will be taken over by the R & B Events LLC group that puts on the various activities such as the Alumapalooza and will known as Alumaflamingo. The dates are February 18-23, 2014 and will be held at the Sarasota Fairgrounds. The rally fee will be \$335. This group will have emphasis on Airstream products, but it will not be a WBCCI activity. We will participate in the rally and it will be a stop on the Florida Fantasy Caravan and some Region 3 events will be scheduled. The website for the Alumaflamingo is: www:alumaflamingo.com. Elna and I have registered for the rally.

Analysis: There are some things that we can learn from this, especially since we are a VOLUNTEER based organization.

- 1. No volunteers, no program. We really need to protect and enhance our volunteer program as this is the biggest reason for the demise of units and programs within WBCCI.
- 2. IRS IS watching us. It cost the Rally here \$850 to file for reinstatement plus additional taxes for being a "profit" group.
- 3. There are groups for profit that may be willing to step up and take over what would be former WBCCI activities.

We have something in WBCCI that is very precious and if not protected, it can be lost!
