## **January 2012 Mid-Winter IBT**

Tathleen Hedgepeth, Region 6 President, along with fellow region members, hosted the Mid-Winter IBT Rally in Hattiesburg, Mississippi, January 9-13, 2012. Eighty-four rigs were on site, plus 14 members staved off-site at local hotels. Representing Region 7 were Linda Agre, Mary Anderson and John Shull, and John and Bobbi Tetzlaff, (Minnesota Unit); Bruce and Gail Harrower, Jerry and Joan Larson, and Don and Lillian Thomson (North Dakota Unit); and Mike and Joan Lahr and Bill and Marti Upton (Wisconsin Unit).

In addition to the WBCCI business meeting, nightly entertainment, a tour of nearby Fort Shelby and Mississippi's Armed Forces Museum, and lots of delicious barbeque meals were included on the rally schedule.

Following are highlights of the Standing Committee reports presented during the business meeting.

The *Blue Beret* Committee Chair stated that some changes to the magazine were necessary due to budget constraints. Also, the new, larger print directory was very well received.

The Budget Committee reported less revenue than budgeted due to less dues income than originally accounted for.

Carolyn Beardshear, representing the Electronic Communication Committee, gave an excellent demonstration on the new. enhanced WBCCI website on a large viewing screen for everyone attending the rally. The committee is developing unit websites at wbcci.net and will continue to work on upgrading the software and adding more services and features. The outdated file server will be replaced and the current database program will need to be updated within two years, as it will no longer be supported.

International President Barry Heckenswiler reported that 323 registrations have been received for the International Rally in Sedalia, Missouri in June.

Don Clark, International First Vice President, announced that Huron, South Dakota, is the site for the 2013 International Rally. The rally theme is "A New Approach." Pearl Adams-Kyle, Past Region 7 President, held a region rally

The Marketing Committee reported that it was challenging to maintain the committee due to minimal budgeted funds from the last IBT meeting (which was necessary to balance the budget). In spite of this situation, they are implementing new marketing ideas in various media vehicles.

The Membership committee reported a drop in membership of 273 members or 4.9% for 5,323 members to date.

Twelve motions were presented during the meeting. The first two motions were for approval of unit flags for the Land-O-Lakes of Ohio Unit and the Alberta/Saskatchewan Unit. Both motions passed.

Motion 3 was an amendment to a motion that was passed on June 27, 2011 to be presented to the delegates in June, 2012. The motion stated "Regular members who are Life Time Members may, upon request, retain their membership as Regular Members if they replace their Airstream manufactured recreational vehicle with a Class A motor

## **President's Message**

#### International Peace Garden Monument Project

Our Club has a unique opportunity to participate in the four-year celebration (2012-2016) commemorating 200 years of peace since the War of 1812 between the nations of the United States of America and Canada by replacing the original WBCCI/Brandon "Hands of Peace" sculpture that was placed in the International Peace Garden in 1975.

The original sculpture, created by artist Barry Burdeny of Canada, was a joint effort by the city of Brandon, Manitoba and the WBCCI. It was dedicated on June 27, 1975 in the International Peace Garden during the International Rally in Brandon, Manitoba. The International Peace Garden is located on the Canadian and USA border between Dunseith, North Dakota and Brandon, Manitoba, Canada. During the early beginnings of the "Hands Across the Border" program between the USA and Canada, this sculpture was a symbol of the achievement by two nations working together for peace, which should be celebrated especially in our international situations today. As of this date, the International Peace Garden's staff has been unable to locate the original WBCCI "Hands of Peace" sculpture, as it apparently was removed several years ago due to its poor state of disrepair.

A motion intended for this project was introduced and passed unanimously by the North Dakota Peace Garden Unit of Region 7 at the Unit's meeting on July 16, 2011, held at the Unit rally in the International Peace Garden. On July 27, 2011, at the Region 7 rally in De Pere, Wisconsin, the Region board unanimously agreed to have the Region 7 President place a motion to create a Special Committee for the International Peace Garden Monument Project on the agenda for the Mid-Winter IBT meeting to be held in January 2012 in Hattiesburg, Mississippi. The IBT approved the motion to form a Special Committee to proceed with this project.

Committee members representing Canada are Gail Harrower, Chair, and Chris Wells of the North Dakota Peace Garden Unit. Representing the United States are Jerry Larson, Don Thomson, and Vern Zink of the North Dakota Peace Garden Unit; Linda Agre of the Minnesota Unit; and Joan Lahr of the Wisconsin Unit. Research to replace the sculpture is progressing with final details to be completed soon. The International Peace Garden is located within Region 7 and committee members are considering staging a Special Event Rally around the dedication of the sculpture. The committee will give a progress report at the June 27, 2012 IBT meeting.

Dedication of this replacement sculpture presents an excellent public relations opportunity for our club. Dignitaries from both nations will be invited to participate in this international event of promoting peace among its peoples. In support of Wally Byam's Creed to us all, representatives from the Airstream Company and Thor Industries will also be invited to attend the ceremony. This is a noteworthy legacy to Wally Byam, his Airstream, and his club, the WBCCI.

Funds will be raised at the region rally in Spicer, Minnesota through our region community undertaking to support this mission.

This project will be funded on donations which are fully tax deductible. The International Peace Garden (IPC) is a 501(c) (3) organization (45-0368420) in North Dakota; and a registered charity (127250181RR0001) in Manitoba. home manufactured by a division of Thor Industries, Inc., the parent company of Airstream, Inc." The amendment requested to delete the words "Life Time Members" and add the following words "Also any person who owns such a Class A motor home may apply for membership in WBCCI." This would allow an owner of any brand motor home to join the club. This motion, an amendment to the June 27, 2012 motion to the delegates, was out of order and withdrawn by its maker, as the current IBT board does not have authority over motions passed by a previous board.

Region 7 presented Motion 4, which requested the

approval of a new Special Committee, the International Peace Garden Monument Committee. This new committee will investigate and oversee WBCCI's participation in the four-year celebration commemorating 200 years of peace since the War of 1812 between the United States and Canada by replacing the original WBCCI/Brandon "Hands of Peace" sculpture that was placed in the International Peace Garden during the 1975 International Rally. The original sculpture has been removed due to disrepair and cannot be found. The cost for this project will be borne by 501(C) (3) tax deductible donations. The motion passed and the committee will present

a report at the June 27, 2012 IBT meeting.

Motions 5 and 6 were considered housekeeping items for the purpose of omitting what are now possible misinterpretations to the club's bylaws. Both motions passed.

Motion 7 requested amending the fiscal year 2011-2012 budget by adding \$9,500 to the Standing and Special Committees budget. This amount was allocated specifically for the Marketing Committee and will create a deficit budget. The motion passed.

Motion 8 was authorization to sign a contract with the State of South Dakota for the 2013 International rally, which will be held at the South Dakota State Fairgrounds in Huron. The motion passed.

Motion 9 was authorization to sign a contract with the Campbell County Public Land Board, CAM-PLEX in Gillette, Wyoming to host the International rally site in 2014. Signing a contract for use of the facilities at this early date will lock in usage charges at the 2011 rates rather than exposing the club to future price increases. A deposit of \$5,000 taken from the 2014 advance funds is required. All funds for the rally will be provided from

fees for attendance, advertising, use and other sources. The motion passed.

Motion 10 requested approval for capital expenditures for a new file server (\$4,000) to be used for the website and data base software, and for a dual platform data base software and licenses (up to \$5,100). The Executive Committee will require adequate documentation prior to the expenditure of these funds. These expenses will assist the **Electronic Communications** Committee to improve several problem areas with possible solutions to improve the website and communications. Since these are capital expenditure items, the cost will be depreciated over their expected useful life. The motion passed.

Motion 11 requested amending the fiscal year 2011-2012 budget by adding \$1,410 to Depreciation Expense. This amount is the estimated depreciation expense for the capital expenditures approved in Motion 10 for the purchase of a server and data base software and licenses. The motion passed.

Motion 12 was a recommendation to the delegates at the June 30, 2012 Delegates Meeting to vote against the motion that allows owners of Thor motor homes to become members of our club. This motion was recommended because of the overwhelming response from members against the original motion and amendment. A vote was passed to withdraw the motion.







It is patterned after the prestigious London to Brighton Veteran Car Run held annually in England. The English Run celebrates the repeal of the 'Red Flag' law in 1896. The law banned the first motorized vehicles from using the road unless a man carrying a red flag walked in front of the car.

The Minnesota Run is a 120 mile American version designed to show case the beauty & endurance of very early automobiles. With the costumed drivers and gleaming vintage cars, the unique event promises 'turn of the century' charm for at least one day. All vehicles are pre 1916 & include bikes & motorcycles, steam & electric cars.
