MINUTES

CHARTER OAK CONNECTICUT UNIT MINUTES OF MEETING ON MAY 5, 2012

MINERAL SPRINGS CAMPGROUND, STAFFORD SPRINGS, CT

- 1 . President Jim Burnham called the meeting to order at 10:35 a.m. There were 29 members present. He led the group in reciting the Pledge of Allegiance and thanked everyone for coming.
- 2. Roll Call of Executive Board and determination of quorum
- 3. Minutes of previous meeting: Not available
- 4. Treasurer's Report: Ending balance \$8584.05.

Jerry moved/seconded by Bill Watts that the Treasurer's report be accepted and filed for audit. Approved unanimously.

5. No new correspondence

6. Report of Committee Chairs:

- a. Legislative: Jerry hopes to get the word Connecticut added to the State flag.
- b. Membership/Evelyn Watts: Membership is the same as last year 74 units. Informational packets for prospective members were made available.

7. Unfinished Business - none

8. New Business

- a. International Election of Officers: Toni Nolder motioned/seconded by Phil that Ray be appointed as our delegate at the International Convention. Unanimously approved. Bill Watts moved that we accept the revised slate of International Officers. The motion was seconded by Toni Nolder and unanimously approved.
- b. Non-Airstream motorhomes: Raymond explained that the proposed By-Law revision will allow Lifetime WBCCI members to stay in WBCCI as long as their RV is a product of the parent company, THOR INDUSTRIES. Bard explained that lifetime members pay their dues in full, upfront, for life. The fee is prorated by age. After much discussion, Jerry motioned to reject the proposed revision. The motion was seconded by Toni and passed with one opposed.
- c. International Constitution and Bylaws Revision: The topic was tabled last year due to insufficient time. There are 40 "unseen amendments" being presented. Lynn mentioned that last year's discussion and minutes laid out the main points of concern by this Unit. The general feeling was that COCU stands by the positions taken and explained in last year's minutes; financial responsibility, Units need to have the ability to be represented either in person, by email or regular mail, opposition to changing the name of the organization, and support for the proposed changes to the complaint process.

Bard spoke to the fiscal responsibility issue. WBCCI had \$3,000,000 in reserves in 2000. The current balance is \$1,000,000. WBCCI has a staff of four in Jackson Center, OH. Membership has decreased and spending has increased. Travel expenses for Regional and International Officers was discussed. Raymond pointed out that reimbursements to Regional Officers have been cut 50% over the last two years and International Officers have had similar decreases.

- d. Lynn motioned/seconded by Bill that Raymond Richards be appointed as our delegate and be given the authority to vote to:
 - Approve amendments as originally presented
 - Approve amendments with any changes made at International meeting that are consistent with the concerns and intentions of the COCU
 - Discretion to vote consistent with guidance from last year's business meeting and today's discussion. Unanimously approved.
- e. Fran moved that we allocate \$100 to Ray and Cynthia to spend at their discretion. The motion was seconded by Jerry and passed unanimously.
- f. Bill Watts moved that COCU not participate in this year's Bulletin Board contest at International. The motion was seconded by Lois and Bob and passed unanimously.
- g. Rich Kushman mailed in a proposal that the Club purchase a Tongue Weight for use by its members. Several members mentioned that Charlie Wilson donated one to the Club and it needs to be located. In light of that, Toni Nolder motioned not to buy the Tongue Weight, seconded by Lynn, and passed.

9. Announcements

- a. Lois shared that Joan Beardsley and her husband, now residing in FL lost their daughter, Diane in a house fire. Members present expressed their sorrow, and signed a sympathy card.
- b. Toni Nolder shared her experiences at the Madi Gras Rally and the Cajun Country Caravan
- c. Incoming President Fran reported that she is hoping to have a joint rally with Cape Cod at West Point. She also hopes to be able to arrange a rally near Lake George during the balloon fest.
- d. She encouraged people to sign up as event leaders.
- 10. The meeting was adjourned at 12:05 p.m.

THE CONNECTICUT STATE FLAG

Since 2003, I have been working with my State Senator Gary LeBeau (CT 3rd Senate District) to have CONNECTICUT added to the State Flag. The current flag shows the motto of our State in Latin "QUI TRANSTULIT SUSTINET". Translation: "He Who Transplants Sustains.

In January, 2003, proposed Bill 342 an Act Concerning the State Flag was introduced by Senator LeBeau to the Government Administration and Elections Committee. The Statement of Purpose of this bill was to make the State flag more recognizable by re-

quiring that the name of the State appear on the flag. This bill was referred to a committee. In other words it was shelved in the committee and no action was expected to be taken.

In March, 2007 I appeared before the committee at a public hearing to testify to the purpose of this bill. My reasoning to the committee was that 27 of the 50 states have the state name on their flag. Also as an Airstreamer when flying the Connecticut flag at rallies in different states, the flag is not recognizable as the Connecticut flag.

After my testimony in April, 2007, a change was made stating that Sec. 63 Section 3-107 of the General Statutes should be repealed and the following substituted in lieu thereof:

This bill was also tabled. But, we had at least gotten to the point where they were describing the color and size of the letters that could be incorporated on the flag. It was suggested that this be a grandfathered flag addition so as not to create any unnecessary cost of replacing all the State flags at one time.

Since 2007, Sen. Gary LeBeau with the help of a Representative from the House has reintroduced the bill but to no avail.

It is my purpose to reignite the effort and get things moving again. I have given some thought and with the consent of Sen. LeBeau of enlisting the aid of our current Governor, Dannel Malloy and Lt. Governor, Nancy Wyman to move this bill forward. ~
