A motion was made by Cordell Woods amend the motion to apply a termination date for certificate. There was no second. There was further discussion among the membership about a top limit on rally fees that would be covered by the certificate. Keith Depre made a motion to put a cap on rally fee covered, for the first rally to new members. After further discussion, the original motion was amended by Keith to offer a free rally fee to new members for their first rally with no cap on the amount of the rally fee. This would apply only to the MN Unit rally fee, and would not apply to ancillary charges for the rally such as tickets to an event. The motion was seconded by Cordell Woods. The motion carried unanimously by the membership.

Unfinished Business:

Creating a Unit flag was discussed. Kay Olsson related the steps that needs to be taken to do this officially with WBCCI including creating the logo, sending it off to International to review, membership vote to adopt logo, send it to Region 7 for approval, then Region 7 sends on to International to approve.
