MINUTES of the INTERNATIONAL BOARD OF TRUSTEES MEETING WALLY BYAM CARAVAN CLUB INTERNATIONAL, INC. HYBRID MEETING WILSON COUNTY FAIRGROUNDS, LEBANON, TN JULY 24, 2021

Constitution & Bylaws Standing Committee Chair Tom Smithson presented his report that included 8 Action Items. All were from Committee and did not need a second:

- Action Item #A requests the movement of International Officers Duties from the WBCCI Constitution to the Bylaws. Without objection, Action Item #A passed.
- Action Item #B requests a new Policy 10.1.1, Duties of the International President, to provide the qualifications and responsibilities of the position. Without objection Action Item #B was approved.
- Action Item #CR-1 requests a revision to the WBCCI Bylaws. Article III., for a new Standing Committee, Nominations, to replace the deleted Constitution Article XIII Nominating Committee. Without objection Action Item #CR-1 was approved.
- Action Item #D requests a new Bylaws Article XVII Constitutional Delegate Voting. Without objection Action Item #D was approved.
- Action Item #E-R1 requests that WBCCI Bylaws Article VI, Club Organization, Sec. 2, insert the word "Constitutional "in front of "Delegate Meeting" and Sec. 6, D be deleted in its entirety

and a new Sec. 6, D be inserted. In Bylaws Article VII, Merger, Consolidation or Dissolution of Local Clubs, Sec. 3, C, delete the words "to vote or otherwise participate in the annual Delegates Meeting." And insert "to vote for International Officers or participate in a Constitutional Delegates Meeting. Without objection Action Item E-R1 was approved.

- Action Item #F requests in WBCCI Policy 9.6.1 Region Operations, Sec. D, Guidelines for Office of Region President, Item 2, Subitem g and Policy 16.6.3 Financial Disbursement, Sec. K, Procedures, Item 3, Subitems c and d, that the word "Constitutional" be inserted in front of Delegates Meeting. Without objection Action Item #F was approved.
- Action Item #G requests a new WBCCI Policy 18.1.1 Timeline and Policy for Proposed Amendments to the International Constitution. Without objection Action Item #G was approved.
- Action Item #H requests a new Bylaws Article IV, Membership and Membership Privileges, Sec. 3. Without objection Action Item #H was approved.

SPECIAL COMMITTEE REPORTS

WBCCI Foundation President Karen Fisher presented her report with updates:

Four (4) \$1000 grants were given out at the Lebanon International Rally to the Girl Scouts of Middle Tennessee, Middle Tennessee Boy Scout Council, Tennessee Outdoors Youth Summit and Tennessee College of Applied Technology Foundation. Funds were designated to provide financial aid for youth from Wilson County to attend camp and to provide educational scholarships to the Auto Tech program at Tennessee College of Technology – Hartsville.

SPECIAL ORDERS

Special Order #1 was the adoption of the Budget for 2021-2022. Eric McHenry deferred to Treasurer Trevor Lake. The Special Order #1 motion for 2021-2022 Budget as presented was approved without objection.

<u>UNFINISHED BUSINESS</u> – None was reported.

NEW BUSINESS

International 1st Vice President Eric McHenry presented a proposal to Restructure International Officer Positions and Terms. After much discussion, the Chair will appoint a Special Committee to research this issue and present a recommendation to the IBT at the Mid-Winter Meeting.

President Mott asked if there was any further New Business. Hearing none, President Mott adjourned the meeting of July 24, 2021 at 10:31 a.m. (Eastern Daylight Time).

President Mott asked Tom Smithson to do the coin toss for the appointing of members to the Nominations Committee. The Region 1st Vice Presidents from Regions 1 – Bard Fuller, 2 - Gary Russo, 5 – Artie Martin, 6 – Jan Heavener, 9 – Nancy Fitzgerald and 10 – Rhonda Levine will serve on this committee.

President Mott made the announcement that 3rd International Vice President Karen Fisher has chosen to accept a three-digit number. Her Airstream Number will be #155 and International Treasurer Trevor Lake has chosen to accept a three-digit number. His Airstream Number will be #309.

Members who have served a minimum of three years as Standing Committee Chair may request a 700 series number upon completion of their third report at the IBT Meeting at the start of the International

Rally. Tom Smithson, Chair of the Constitution and Bylaws Committee and Hedda Smithson, Chair of the Publications Committee have requested such a number. Their Airstream Number will be #777.

It is customary at this time for incoming Region Presidents to accept a new 3-digit Airstream Number. Some Region Presidents may choose to keeps their current Airstream Number. Region 4 President Brad Briggs has chosen #215 for his new Airstream Number, Region 8 President Greg Vadner has chosen #270 for his new Airstream Number and Region 12 President LaVerne McHenry has chosen #253 for her new Airstream Number.
