The MN Airstream Club voted at the Fall 2021 rally to create an official club logo and flag. We had been using a couple of unofficial logos for many years, but we wanted a flag to identify our club beside the Minnesota State Flag. The club voted to form a flag committee to design the



new logo and flag and then present it to the club membership for approval.



The Flag committee included Chuck Dodd (Immediate Past President), Terry Pfleghaar (Current President), Pete Yanke (Trustee), Chris Olsson (Webmaster), and Gary Burnham (Artwork Designer Extraordinaire). Using one of the unofficial logos as a starting point, Gary designed the new logo and flag. There were several iterations presented to the Flag Committee (thanks for your patience with us Gary), and through much discussion and review by Tom Smithson (Constitution/bylaws Chair for IAC), we settled on the flag and logo. (Flag is shown on page 4) One thing we learned is that the identity of the WBCCI/ WBAC/AIC Airstream Club on the flag needs to meet strict requirements. We originally were g oing to have the letters WBAC on our flag, but that is not one of the approved options. So, we changed it to WBCCI, and all is good. One other note is that while WBCCI is included on the flag, it is not required on the Logo itself, hence the difference between the logo and flag.

The new logo and flag were presented to the club membership at the holiday party on Dec 18th and approved. We filled out an IBT Motion form to request approval, and forwarded to Jane (R7 President), who approved and forwarded to International to be placed on the next IBT agenda. The IBT approved the flag and logo during their February 2022 meeting. Hooray!

### MidWinter IBT Motions

*This info was sent to your club President recently regarding the motions from the Mid-Winter IBT* 

There were three motions during the MidWinter IBT that required discussion. The first was about restructuring the Executive Committee (EC), the second was simplifying the process for constitutional changes and disconnecting the delegate voting from the International Rally (thus allowing it to be held when it's needed), and the third was about allowing local clubs, rally hosts, etc. to set guidelines for COVID-19 vaccination status.

The restructuring proposal would change our EC to work like many other organizations, both nonprofit and corporate. WBCCI members would vote for 7 director positions, then the IBT would vote for a President, Vice President, Secretary, and Treasurer from the directors. The directors would have two year terms, staggered so that we would elect 3 one year and 4 the next. There would be no change to the Regional Officer roles; they would still be elected and serve as we do now.

A concern I've heard is that we are moving quickly on it, which I also expressed when I first heard the proposal in December. The proposal has now been fleshed out. More information will be forthcoming in the Blue Beret and the club website, then it will be voted upon at the delegates meeting in Maine.

The second motion simplifies the process for submitting and ratifying an amendment to the club's constitution, and decouples the delegates meeting from the International Rally. These changes will reduce the number of meetings held at International, making the club more flexible. If approved by the delegates in Maine, changes to the club constitution will require at least 2/3rds of the members to approve it, as long as at least 20% of the members have voted.

The final motion would have allowed clubs, caravan hosts, rally hosts, and people in similar positions to set a COVID-19 policy for events beyond what the local, state, provincial, and federal governments require. This motion was narrowly defeated - the vote was 9 to 8. So, the current policy remains in effect -WBCCI events must follow local guidelines and cannot impose additional guidelines beyond those.

The new Grapes and Grains Intra-club and the Future Streamers Intra-Club both received permanent charters. The Grapes and Grains Intra-club is intended for people to share their interest in wine, brandy, spirits, and beers. The Future Streamers Intra-Club is a club designed to keep our youth involved in Airstream activities.

As of mid-January, there were 829 campers registered for International in Fryeburg, Maine. Also, the club has 7,339 active memberships as of January 20th; we haven't seen numbers this high since about 2001.

# A Trip to the Spa

A few years ago, my younger son Andrew announced that he had registered for an Ironman Triathlon in November in Tempe, AZ. My first reaction was, November?, and my second reaction was, great opportunity for a trip in the camper! The actual date of the race was November 21, a few days before Thanksgiving.

After doing my usual investigation of route, distance (1850 miles approximately), weather, and all the other important things, I determined that the weather would be decent (no ice or snow forecast), and that five days on the road would get me to the Tempe area in plenty of time to do a bit of sightseeing before the race. At the time, I was still living in southwest Michigan, and Andrew was living near Manitowac, WI. He would fly to Arizona, and I would take my camper and traveling companion.

I went on line to make a campground reservation in Mesa, AZ, but two days later I received a message that my vintage Airstream was "too old" to be allowed in that park. What? My next attempt was successful, with a reservation at a beautiful, almost brand new campground, Eagle View, just south of Fort McDowell, AZ, for 7 days.

This park was beautiful if a bit stark, but then it was Arizona. It had very large cement pads, lots of space between sites and all the hook ups needed for comfort. I was about ten miles from the actual starting point of the Ironman, and it tuned out that the road in front of the campground was part of the bike race route. My son, who was staying in Tempe, was delighted to ride his bike to my camp site, getting in some practice and visiting me at the same time.

If you're not familiar with the Ironman Triathlon, it starts with a 2.4 mile swim, usually in a lake, then a 112 mile bike ride, and finally a 26.2 mile run. The folks who do these races "professionally" will finish the course in about 10 hours and the "amateurs" must complete the race in under 17 hours or be disqualified.

Knowing that I had to be in Tempe by about 6AM on race day and that I might not be back to my camper until after 11PM, I knew I had to find a place to leave Angus, my traveling companion. A very nice lady at the park reception desk told me there was a lovely kennel just a mile away. What could be better? I called the kennel and made a reservation for Angus to stay for two nights.

When I arrived at the kennel the day before the race, I was surprised by how large it was and by how many employees seemed to be there. When I gave my name and reservation dates, I was handed a "menu." Hmmm. There were choices of play time, individual or group; treats, ice cream, peanut butter kong, homemade cookies, etc.; and multiple grooming options. Each choice had a price following it. The kennel I used at home asked three questions: was the dog current on inoculations, did you bring food for the dog, and when will you be back? Because I was stunned by the selections (and prices), I agreed Angus could have one peanut butter kong a day.

I am very proud to say that my son completed the Arizona Triathlon in just over 14 hours, and I have pictures to prove it.



He was exhausted by the event, and I was exhausted by standing around all day hoping to catch a glimpse of him during the race!

The day after the Ironman race, I returned to the kennel to pick up Angus. I announced who I was and that I was picking up Angus. A man approached with a very stern look on his face. Hmmm. He proceeded to explain that "he" had had some problems with Angus. (This had NEVER happened before when I left Angus at a kennel.) What was the problem?, I asked. Of course, I thought the worst. The man explained that he had been Angus's "trainer" during his stay and that Angus insisted upon trying to herd the other dogs during group play time. The result was that Angus had to be put in "time out." What??? Angus IS a herding dog, a Red Heeler. I apologized for my dog's behavior (against my better judgement) and asked for the bill, which I did pay.

A few minutes later, the man brought Angus out from the back area, and I was shocked. Angus's eyes were huge, with the whites showing, his tail was between his legs, and he looked petrified. I quickly put him on his leash, mumbled a thank you, and left as fast as I could. When I got to my truck and had opened the door, I stooped down and hugged Angus for a long time, trying to reassure him. I then make him a promise. I would NEVER leave him in a place like that ever again. And I haven't. When Angus and I left the campground the next morning, we went by the kennel, I repeated my promise to him, and I "waved" at the kennel!

Since we were in Arizona, I couldn't pass up the chance to see more of the state, so we headed southwest instead of northeast toward home. We then spent 3 days in the Tucson area, just in time for a cold snap where temps at night went down to 30. I reminded myself that I lived in Michigan, and it was November. It was a beautiful and very different adventure, and the most annoying thing for Angus was the cactus needles that seemed to be everywhere we walked, even if there were no cactus in sight! I soon learned from a neighbor in our campground that duct tape works wonders on paws.

After almost three weeks on the road and almost 3,500 miles on the odometer, we arrived home just in time to winterize the camper. We were blessed with very fine weather the whole trip, and we met many pleasant people. Angus forgave me my choice in kennels, recovered from his kennel trauma and had the best time sleeping while I drove back home.

I'm still trying to figure out how you put a dog in a time out!
