The Spring General Business Meeting of the Central Indiana Unit of Wally Byam Caravan Club International was called to order by President Mike Zimmermann at 7:45 P.M.

Time being an issue, the treasurer's report was not read. Since the minutes from the October 2009 had been emailed to all members, they were asked if there were any additions or corrections. There being none, it was moved and seconded and passed that minutes from last meeting be accepted.

New Business-

<u>Amendment of CIU bylaws and Constitution</u> Mike explained the proposed amendments of the bylaws and constitution: to include "email" as an official means of communication and called for a motion to accept these changes.

to allow an Affiliate Member of this unit who is a regular member in the same region to be appointed as a delegate, if the unit has no regular members who are attending the Delegates Meeting.

to hold the annual business meeting of the Unit during the month of September or October (depending on fall rally dates). It was moved by Barry Bell, and seconded by John Himmelheber to accept these changes. The motion was passed unanimously. Russ

Thackery reminded the group that changed Bylaws may need to be re-approved by the National organization.

Election of National Officers

Mike asked for a motion to approve the slate of national officers. It was so moved by Ray Brunk, seconded by Russell Thackery and approved unanimously.

IBT Motions for the International Rally

It was noted that motions on which the delegates vote to change the constitution must be passed by the units. IBT motions are bylaws and do not have to be voted on by the units.

Mike brought up six IBT motions which will be voted on at International. A copy of these will be sent to the membership for their opinions, which will be forwarded to Louise Humble, action Reg. 5 president. The opinion of the unit can be reported as a vote or as an opinion, at the discretion of the unit president.

Motion 1 WBCCI yearly dues will be increased to \$65 and lifetime member dues will be recalculated accordingly.

Motion 2: The International treasurer, with the approval of the president, is authorized to invest WBCCI monies in a variety of funds, including secured mutual funds. Total amount of funds at any one financial institution should not exceed the FDIC insured amount.

Motion 3 : Life membership funds shall be deposited one or more eligible securities, at the discretion of the international treasurer.

Motion 4: No officer or representative of WBCCI shall agree to a contingent liability in excess of \$20,000 without specific prior approval of the Executive Committee of the International Board of Trustees.

Motion 5: A separate criteria will be created for sanctioned caravans. If the unit puts the NUMBERED UNIT CARAVANS in its minutes, it is eligible for caravan insurance. This allows for shorter caravans to be listed in the caravan directory after members' names.

Note: If this motion passes to have a caravan numbered, the information must be sent to the caravan chairperson and approved before the caravan can be numbered and publicized.

Motion 6: The name of the international treasurer will be removed from all documents pertinent to caravans.

PROPOSAL TO AMEND THE WBCCI CONSTITUTION.

Louise Humble explained the process by which a motion proceeds to an amendment of the WBCCI constitution. There was no discussion of the proposed amendment.

The Rally Fee of \$6 per person was announced.

The following caravans to Gillette, WY in June were seconded and approved.

There being no further business, a motion to adjourn was made and accepted. The meeting was adjourned at 9:50.
