Mike and Carol have planned several activities to keep us busy. There will be a car caravan to the Indy 500 Qualifications on Saturday for those who want to see the action. There should be plenty, with there being only one week-end of qualifying this year. The Fairgrounds campground has complete hook-ups and level parking with a fenced, secure area. We will have a general business meeting on Friday with voting on some important issues. So be sure and get your reservations in . — There is a registration form elsewhere in the Ticker. (There really is—not like last issue when I skipped over it.)

REPORT FROM MID-WINTER INTERNATIONAL BOARD OF TRUSTEES MEETING IN RAYNE, LOUISIANA These will be discussed at the Crossroads Rally business meeting.

Changes enacted:

- 25 percent reduction in International Officers expenses
- 10 percent reduction in Region officers expenses
- A marketing plan has been funded and is being implemented
- Two year budget planning.

Eight of the motions considered had to do with changes in the grievance procedure. Pres. Tom Collier noted that in 2009 more grievances were filed than in any other year in the history of the club. A motion to add the actions of suspension or probation to the appeals process was rejected.

Motions approved: To allow Unit executive boards to appoint , Unit delegates to the annual June meeting.

Motions defeated: make the Mid-Winter IBT like an International Rally event, and to do away with proportional voting by the delegates.

Motions withdrawn, but under future discussion

Reorganize the WBCCI into 7 regions rather than 12 Make the International Rally a rotating Region function rather than the responsibility of the International president.

Remove the position of International 3rd Vice-President. Reduce the responsibilities for International and Region officers travel.

CENTRAL INDIANA UNIT DUES

The Executive Board at the Spring Luncheon meeting voted to increase the unit dues from \$10 to \$15 per year. The following is a brief summary of the justification for this increase.

The cost of operating the Central Indiana Unit of WBCCI has been on the rise for some time. Rallies and luncheons must become self-sufficient, and we must look at a dues increase to help cover the increasing non-rally related operating expenses. These include Ticker and Directory printing and postage, dues processing materials and postage, Pastpresidents flags and badges for new members and new officers. We also have expenses related to the Region rally and activities at the International Rally (door prizes, bulletin board, parade, etc.) We will definitely look at reducing our spending, but a dues increase is also needed to help keep CIU operating.

Changes to Central Indiana Unit Bylaws and Constitution

Only the <u>underlined words</u> are changes.

- The Recording Secretary shall mail <u>first class or email</u> copies of Board Minutes to the members of the Executive Board
- An Affiliate Member of this unit who is a regular member in the same region may be appointed as a delegate at the International Rally if the unit has no Regular Members who are going to attend the Delegates Meeting.
- These Bylaws may be ... provided the proposed amendment has been submitted in writing, <u>first class</u> <u>mail or email</u>, to all Executive Board members ten (10) days prior to such meeting.
- The annual business meeting of the Unit shall be held during the month of <u>September or October</u> (depending on fall rally date). ...Meetings shall be announced to the members in writing, by <u>first</u> <u>class mail or email</u>, at least fifteen days prior to the meeting.
- Ballots submitted by <u>email</u>, regular mail or facsimile may also be accepted from regular members unable to attend regular or special business meetings.
- Any Article or Section of this Constitution may be amended by a two-thirds vote of the members present and voting at a business meeting of the Unit or a special meeting ... providing ... a notice containing the proposed amendment or amendments has been mailed first-class <u>or emailed</u> to each member of the Unit at least fifteen days prior to such a meeting.

CIU POLICY CHANGE

The following Policy was amended at the Executive Board Meeting on April 24, 2010 at Greenwood, Indiana. Only the words underlined were changed in the Central Indiana Unit Policy.

• The official publication of the Unit shall be called "The Ticker". It shall be published before each unit event and mailed <u>first class or email</u> approximately 20 days before each unit rally and dinner meeting. The Ticker Chairman shall obtain information from the President for inclusion in each issue.
