If you are coming from IN37 (North of Noblesville) go WEST on 206<sup>th</sup> St. (3.5 mi) Turn RIGHT onto HAGUE RD(0.3mi) Turn onto CARRIGAN RD (1.0 mi) Turn LEFT onto N HARBOUR DR (0.2 mi) Turn LEFT onto LONGFORD WAY (0.1 mi) Turn RIGHT onto REGENTS PARK LN (0.2 mi)

#### Central Indiana Unit (05-041) Wally Byam Caravan Club International, Inc.

The following are additional provisions for the government of the unit as permitted under Bylaws, Article X.

The Motto of the Unit shall be "Heart of Indiana".

The official publication of the Unit shall be called "The Ticker". It shall be published before each unit event and mailed approximately 20 days before each unit rally and dinner meeting. The Ticker Chairman shall obtain information from the President for inclusion in each issue.

The Historian shall keep account of all activities of the unit including publications; programs and photographs donated by members or others.

The fiscal year shall be October 1 to September 30.

Flowers and Memorials for a newly deceased unit member or friend shall be funded by individual dontions received for that specific purpose. To this end, the Unit President may appoint an ad hoc chairman to make necessary arrangements, receive donations, and disburse those funds.

The Executive Board shall have authority to award a life membership, in the Unit, to any Past President of the International Club and his or her spouse; such life membership, however to be valid only as long as the holder or holders thereof, remain otherwise eligible for membership in WBCCI.

It is the policy of this Unit to appoint the Immediate Past President and two of the most recent active Past Presidents to serve on the Nominating Committee.

At the Annual Membership Meeting, 9/30/2006, the membership voted to make a gift each year of \$500 to the "Cents for Kids" at the International Rally for the next five (5) years. That would encompass the International Rally years of 2007, 2008, 2009, 2010 and 2011.

At the Annual Membership Meeting, 9/30/2006, the membership voted to plan Unit Rallies and Parties at a reduced rate (loss) until the Unit Treasury reaches \$3500.

Former Unit members, who no longer own a recreational vehicle manufactured by Airstream, Inc. but who wish to keep in contact with the Unit, may, at the discretion of the Unit Executive Board, be sent copies of the Unit newsletter and Unit Membership Directory. Such former members shall be charged an annual fee to be determined by the Unit Executive Board at the annual fall meeting. This charge is not to exceed the amount of the annual Unit dues for the Unit Newsletter and Membership Directory.

Expenditures for any special project that shall exceed \$50.00 must have prior approval from the President or Executive Board.

These Policies were adopted on <u>September 20, 2007</u> at <u>Loudonville, Ohio</u>. Revised, October 4, 2008, Palestine, Illinois.
