

Minutes of General Business Meeting – Central Indiana Unit of WBCCI 041 Miami 4-H Fairgrounds, Peru, Indiana October 8, 2012

President Mike Brown opened the meeting at 7:00 p.m. with the Pledge of Allegiance. Secretary Mary Jo Brown took roll call.

There being a quorum present, the meeting was called to order.

Mike Brown made a motion that, since each member of the Board had received a copy of the minutes of the April 28, 2012, meeting via e-mail and had the opportunity to review them, we waive the reading of the minutes. Mary Jo Brown seconded it and the motion carried.

Treasurer's Report

Ron Gordy distributed copies of the Treasurer's Report as of October 5, 2012, the date he closed the books. He stated that the checking account balance as of that date was \$1,663.22, and the savings account balance was \$3,007.21, for total assets of \$4,670.43. Dues in advance for 2013 were \$450.00, for total equity of \$4,220.43.

Income since the last report in April 2012 is \$1,430.00 from International dues, \$445.20 from Unit dues, \$1,283.00 from rally income, \$0.74 from interest and \$26.00 miscellaneous income, for total income of \$3,184.94. Expenses were \$1,300.00 for International dues, \$513.06 for building and grounds, \$531.89 for rally supplies and food, \$120.00 for door prizes, \$9.00 for Ticker postage, \$89.39 for administrative expense, \$4.09 for new member postage, and \$73.32 miscellaneous unit expense, for total expense of \$2,640.75, and net income of \$544.19.

Ron reminded everyone that our unit now has the capability of making payments by credit card or PayPal. He pointed out that there is a small fee incurred for using these options, and that is the reason for the uneven dollar amount in the unit dues of \$445.20

Memberships paid so far for 2013 are 29 regular members, 4 affiliates, and 1 subscriber.

A motion was made by Ken Langell to accept the Treasurer's Report as submitted. Bud Hershberger seconded it and the motion carried. A copy of the Treasurer's Report will be filed with these minutes for audit.
