Greetings Washington Airstream Club Members!

Richie Stolarik imparted his Salmon baking wisdom on a new class of volunteers and taught them how to make a delicious meal that we will all enjoy next year.

I want to thank the Unit Board of Trustees for their tireless efforts this year focusing on not just the fun stuff, but for looking after the Unit's interests and navigating our way toward 501(c)7 compliance. As a board, we had to absorb a lot of new information, work with attorneys, partner with the WLYH Board of Directors and get input and support from Unit members on the necessary changes. Some very challenging decisions had to be made and some of them were unpopular, but all were done with the interest of the Unit as the priority. So many contributed to the success of this year's efforts that I would need multiple pages to thank them all properly, so I'll just mention a few. I am so grateful to Diane Carpenter, our Unit 1st Vice President, for picking up the slack on rally planning and for her moral support and to Mike Plympton, President of WLYH, for his dedication as we collaborated and navigated toward IRS compliance. Darlene Leslie, our Assistant Secretary, was a huge source of support on Unit history and reminded me frequently of the need to get my article done on time for this Newsletter. Past Unit President Craig Hammond served as a great sounding board and Carol Ortiz, our Unit Parliamentarian and keeper of the rules helped me avoid meeting blunders.

Please join me in thanking all our club leaders whether they served on one of the boards, or as a passionate committee member or as a volunteer for a rally. Volunteering is what keeps our club running and is the most impactful way of demonstrating our commitment to the principles of our club and each other. I look forward to seeing you all at the upcoming Election Rally!

The purpose of the following procedure is to ensure that no member votes more than once and to ensure confidentiality of the ballots.

Washington Airstream Club Voting Procedures

There are two methods of voting for club officer positions (prior to the meeting and in person at the meeting).

Voting prior to the meeting day (Two Options)

Using the Newsletter Ballot

The ballot in the newsletter may be filled out and inserted in an envelope with your Big Red Number on the outside. That envelope may then be dropped off or mailed to Julie Hockaday, 9101 Steilacoom Rd SE #27, Olympia, WA. **Deadline for this manner of balloting will be two days before the Election Membership Meeting.** The envelopes will remain sealed and be held in a secure place until after voting is done at the meeting. Reconciliation of the Big Red Numbers will be done by the Recording Secretary or Corresponding Secretary against the Membership List before the meeting.

Using Survey Monkey

To use Survey Monkey each voter must have a separate email address. Each voter will complete and submit their ballot on line. **Deadline for voting using Survey Monkey will be two days before the Election Membership Meeting.** These ballot results will be provided to the Recording Secretary or Corresponding Secretary for reconciliation with the membership list before the Election Membership Meeting. The individual ballots will be kept confidential. Only names of those who voted will appear.

Voting in person at the Election Membership Meeting

Prior to the meeting two Tellers (ballot counters) will be selected from affiliate members or members of another local club. Their job will be to tabulate all the ballots and provide totals to the BOT President.

Prior to the meeting the Recording Secretary or Corresponding Secretary will have a reconciled list of received ballots.

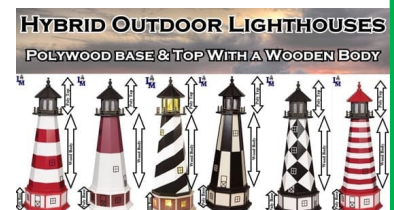
Members attending the Election Membership Meeting will check in with the Recording Secretary to confirm voting eligibility from the reconciled list and receive a ballot. **Voting will continue from the time the doors open until ten minutes before the Election Membership Meeting comes to order.** Ballots will be collected in a secure container and the selected Tellers will tabulate all of the ballots (from two days prior and the day of the meeting) during the Membership Meeting and submit the results to the BOT President before the adjournment of the meeting.

Harbor Light Project
