### VII. Reports of Officers and Committees

#### A. President's Report – Bob Masters

1. Club Size has grown to one of the Top 5 Clubs out of 104 Clubs.

- B. Secretary Janet McGloin
  - 1. Minutes from the October 23, 2021 meeting were sent to the Executive Board on November 2, 2021.
  - 2. There were 12 motions voted and passed electronically by the Executive Board since October 2021. This is the second year that electronic voting was successfully used for the Voting Membership. - C. Audit Committee Larry Scovotto and Steve Kane
  - 1. Audit completed by Audit committee, no issues noted, see FAC 2022 Audit Committee Report attachment for details.
- D. Treasurer Brenna Loretta
  - 1. Verbal report of details on the "FAC 2022 Treasurer Club Budget Performance" Attachment.
- E. Badge Committee Steve Kane
  - 1. Reported that they have a few badges left for this year and have entered an order for badges for next year.
- F. Charitable Project Committee Chris Allen
  - 1. Fisher House is our Club's Charitable project.
  - 2. Since November 2018 the Club has donated \$14,754.
- G. Communication Committee Randy Godfrey
  - 1. Randy Godfrey reported the committee is comprised of Social Media Judy Barrett, Newsletter – Susan Poole, and webmaster – Steve Oppel.
  - 2. We currently are sending the newsletter to 436 member emails and 121 affiliate member emails using MailChimp to build the distribution list.
  - 3. Susan Poole discussed the purpose and details about the newsletter, which is published 6 times per year. She encouraged suggestions and feedback from the members.
  - 4. Steve Oppel discussed web page content and reported there is now a messaging system for Webmasters called Slack. It is possible we may be moving to Jotform where you can pay for the rally electronically.
  - 5. Judy Barrett discussed Club social media/facebook page. It is limited to members only and is not a public page. She monitors the facebook page to ensure that only club related information is on it.
- H. Membership Committee Nelson Arias
  - 1. Bob Masters provided verbal report for Nelson Arias. The club currently has 493 Regular members and 129 Affiliates which is a growth of regular members of 121% since 2019.
  - 2. General discussion: Our members believe that the friendliness of our club, the number and diversity of our rallies/activities, the newsletter/website, FAC custom badge, and our charitable cause all contribute to increasing membership.
- I. Rally/Caravan Committee Larry Scovotto
  - 1. Larry Scovotto reported for 2023 there are currently 10 rallies approved. The rally schedule can be viewed on the Website.
  - 2. The Annual Meeting for 2023 is planned to be held at the Clermont Rally in October 2023.
