## IOWA CLUB RALLY RESERVATIONS ARE AVAILABLE NOW

If you haven't already sent your reservation check to either Tom and Shirley Herron or Kathy Allen for the **May Rally** in Winterset, IA, you need to get it done. You were asked to do that by mid-November, but it may not be too late, if you do it right away. The minimum check needs to be made out for \$25.00, covering one night of camping plus a one-time \$5.00 reservation fee. If you know how many nights you plan to camp at the Winterset Municipal Campground, you can send a check for \$20.00 per night plus the \$5.00 reservation fee. Should you need to cancel, all but the \$5.00 reservation fee is refundable. If you send in a check for just \$25.00, you will need to send a check of \$20.00 per night for additional nights in the spring of 2023. You will be reminded in a future newsletter. Remember, the May rally will be on the first weekend instead of the usual second, because Mother's Day falls on the second weekend.

Reservations for a spot at the **June Rally** in Allison's Wilder Park Campground can now be made. The website is **visitwilderpark.com**. The rally dates would be June 8-11, our normal Thursday afternoon to Sunday morning period. However, if it is at all possible for you to stay over Sunday evening, include that night in your reservation, since at 6:30 PM, there is a free concert by the Glen Miller Orchestra. John and Carol Heckman, our rally hosts, attended last June and Carol stated that it was a WONDERFUL experience. Obviously, you can come earlier and stay later if you so desire. The free concert draws lots of people, many of whom use the campground. Therefore, in order to make certain you have a spot, it is QUITE advisable that you make your reservation as soon as possible, even though you may not want to stay for Sunday night. That would assure that you have a spot for the actual rally days. If you have problems navigating the reservation site, you can phone the Allison City Clerk's office at 319-267-2245 for help.

Also, you should make a reservation for the **August Rally** in Terrace Campground at Westlake County Park on the west side of Davenport, IA. Reserve now, since that campground is very, very popular. All sites in Terrace Campground are full hookups. The dates for that rally are August 10-13, 2023.

There will be a Region 8 Caravan to the International Rally in Rock Springs, WY, organized by Joe Hauser of the Greater St. Louis Airstream Club. He asks that the following information be provided to all Iowa Club members.

If you are planning to caravan to the 2023 International Rally at the Sweetwater Event Complex in Rock Springs, WY this June, the following caravan is being offered. This caravan is open to any Airstreamers, especially all of Region 8. The caravan will arrive three days early at the rally location, on June 21<sup>st</sup>. Be sure you have registered for early arrival with the rally. Join the caravan at any of the stops along the way. The caravan is set up from St. Louis to Rock Springs and is all on four-lane highways.

Everyone makes and pays for their own reservations and sites. When making reservations, identify yourself with the Greater St. Louis Airstream Club, regardless what club you are from.

**The first stop is in St. Joseph, MO** (266 miles, 4 hr. 10 min from Wentzville, MO). Arrive at the AOK Campground and RV Park on June 18<sup>th</sup>. Depart on June 19<sup>th</sup>. **They are accepting reservations now!** Address: 12340 County Rd., 360 St. Joseph, MO 64505. Phone is 816-324-4263 and their website is aokcamping.com

**The second stop is in Kearney, NE** (263 miles, 3 hrs 52 min.) Arrive at the Kearney RV Park on June 19<sup>th</sup>. Depart on June 20<sup>th</sup>. **They are accepting reservations now!** Address: 315 M Ave., Kearney, NE 68847. Phone is 308-237-7275 and their website is kearneyrv.com.

**The third stop is in Laramie, WY** (365 miles, 5 hrs 20 min.) Arrive at the Laramie RV Resort on June 20<sup>th</sup>. The end result is that you will be receiving the latest (and, hopefully, the last) update via email and will be asked to indicate your approval, or disapproval, by return email.
