- 2. Improvements to the Rally Registration Process, Carmen Ortiz as distributed electronically on 9/12/2023 and approved electronically.
  - a. No more paper coupons, all registration will be done through Jotform.

- b. The Jotform will be activated on the first of the month at 9:00 am, first come first served, reservations are time stamped as they are received by the NorCal registrar. Rallies are listed in the Poppy and on the Website.
- c. You must double check your Jotform BEFORE submitting it by hitting a review button.
- d. Once you have received confirmation of registration (not merely that a form was submitted) from the NorCal Registrar, you need to pay by Zelle or by check.
- e. Registered participants need to communicate to the NorCal Registrar about any changes in their reservations, even while on site. NorCal Registrar will contact those on the waiting list about any changes after the rally is filled (you may not give away your site).
- 3. Bylaws (Committee Members- John Bibby, Kent Schroeder, Brian Scheuer, Claudia Marston, Chair-Hedda Smithson). *Motion*: that the proposed amendments to the leadership guides and Bylaws submitted by the CBL committee be approved. Vote to *Approved*. They will be posted on the website and distributed to the membership.
  - a. TABLED. Further expansion of Leadership Guides to cover NorCal Registrar duties.
- 4. Number of Hosts and Apprentices per Rally and Free nights (agenda items #4 & #6, these discussions were woven together). Jim Christie & Carmen Ortiz
  - a. There was a discussion of the number of Hosts, Co-Hosts and Apprentices per Rally, in regards to free camping sites. Currently we have 2 Co-Hosts per rally, with apprentices or helpers as needed and allow for 2 free nights parking for the Co-hosts. Each Co-Host gets a free night's parking, unless they wish to donate it to an apprentice or helper. Additional hosts, apprentices or helpers are not offered free parking nights. That was confirmed as how it stands in our bylaws and constitution.
  - b. Free Night at rallies, Jim Christie & Carmen Ortiz
    - i. Discussion of who is entitled to get the free night of parking, referred to in the Minutes section 4 as these discussions dovetailed.
    - ii. *Motion*. Bob Verdegaal moved that if a single host does a rally, they receive 2 nights of free parking. It was seconded by Jim Christie and *approved* with one abstention.
  - c. TABLED. Discussion of Rally Fee was tabled until December 2023.
- 5. Rally Participation for Members who book their own sites, Lori Bibby, Rally Handbook Committee
  - a. *Motion*: It was moved by Carmen Ortiz that rally registration is done only through the official process of filling on the Jotform and sending payment. Participation in rally is only for registered members who have an assigned site, although unregistered Board members may attend Executive and Business meetings. Seconded by Bill Maffei, *approved unanimously*.
  - b. There are several 2024 rallies where attendees must book their own sites. Once booked, the site information needs to be forwarded to the NorCal Registrar and the Jotform when released must be completed and paid for to be a rally participant.
  - c. There was a discussion of NorCal liability and insurance at rallies. Insurance only protects the Board Members from liability should anything happen.
  - d. TABLED. Further discussion of self-registered camping at rallies and rally priorities.

- 4. Bylaw changes as submitted by the CBL committee were approved.
- 5. Each rally has 2 free parking nights, either for 2 Co-hosts or 2 nights for a single host. Additional hosts, helpers or apprentices will not received a free night unless the hosts surrender one night to them.
