- Update on NorCal, Greater Bay Area and Sacramento Valley combined Rally. On May 1, 2024 registration for the combined clubs rally at McCloud RV park in September will begin. It will be a 2-part registration process, where you will register by jot form and be given access to a reserved

site. You will then make your park reservation directly and once you have a site number you will go to the jotform again and make meal and activity selections.

## **New Business**

- The Rally Planning Guide has been updated and will be on the website as soon as it is approved.
- Cancellation Policy:
  - o Any amounts for things not used are refunded.
  - o If a wait list person steps into your relinquished spot, you will get a full refund.
  - No rally fees are refunded
  - Host will get funds for expenditures that are dependent on attendance (catering, events, tours).
  - Refunds are completed after the rally is over at the close out of the books. You may wait
    1-2 weeks after the rally for your refund.
  - To hosts -a written explanation of your costs, minimums and limits will help with the determination of refunds. Caterers may have a minimum number of meals, dates by which they need to have realistic numbers, events or sites may have something similar.
- Region 12 has a change to policy #5 to establish a permanent regional rally planning committee. Doug Fitzgerald is currently working on 2024 Region 12 rally.
- There will be no May Board Meeting, next meeting will be in June in Quincy.
