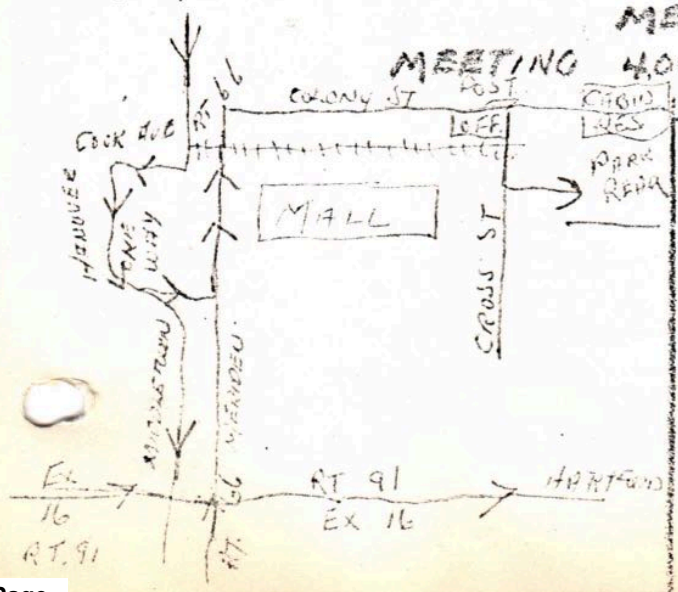

MEETING MINUTESCHARTER OAK UNIT

January 3, 1971

The January meeting was called to order at 4:50 P.M. by President Raboin at the Cabin Restaurant in Meriden with 35 members present.

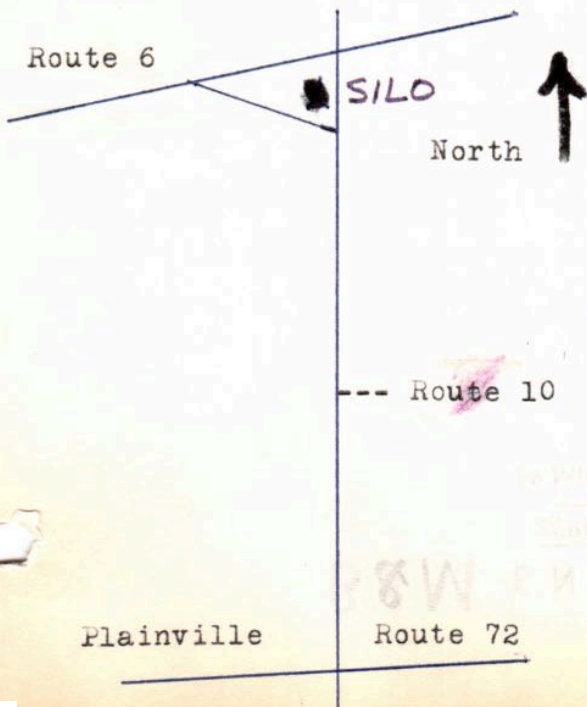
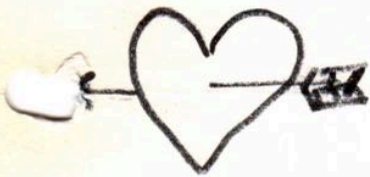

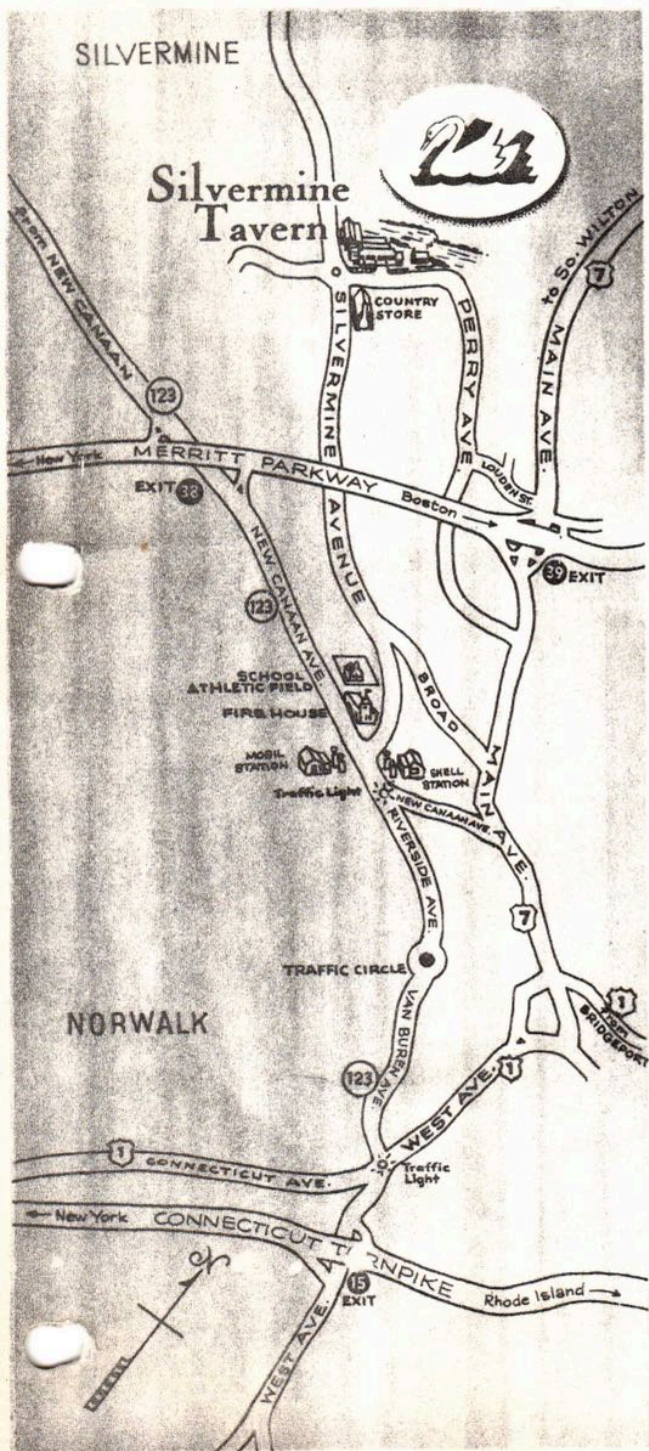

CHARTER OAK UNITMEETING MINUTES

March 7, 1971

The March meeting was called to order at 4:10 P.M. by President Emile Raboin at the Silvermine Tavern in Norwalk, Conn. There were 40 members present.

Mr. Hulbert led the group in the pledge of allegiance.

The secretary's report was read by Kathy Dirga. A motion was made by Tom Brennan to accept the minutes and it was seconded by Rae Brennan.

The Treasurer's report was read by Fern Faboin. The balance on hand is \$129.56. A motion was made by Rae Brennan to accept the report and file for audit and it was seconded by Audrey Clark.

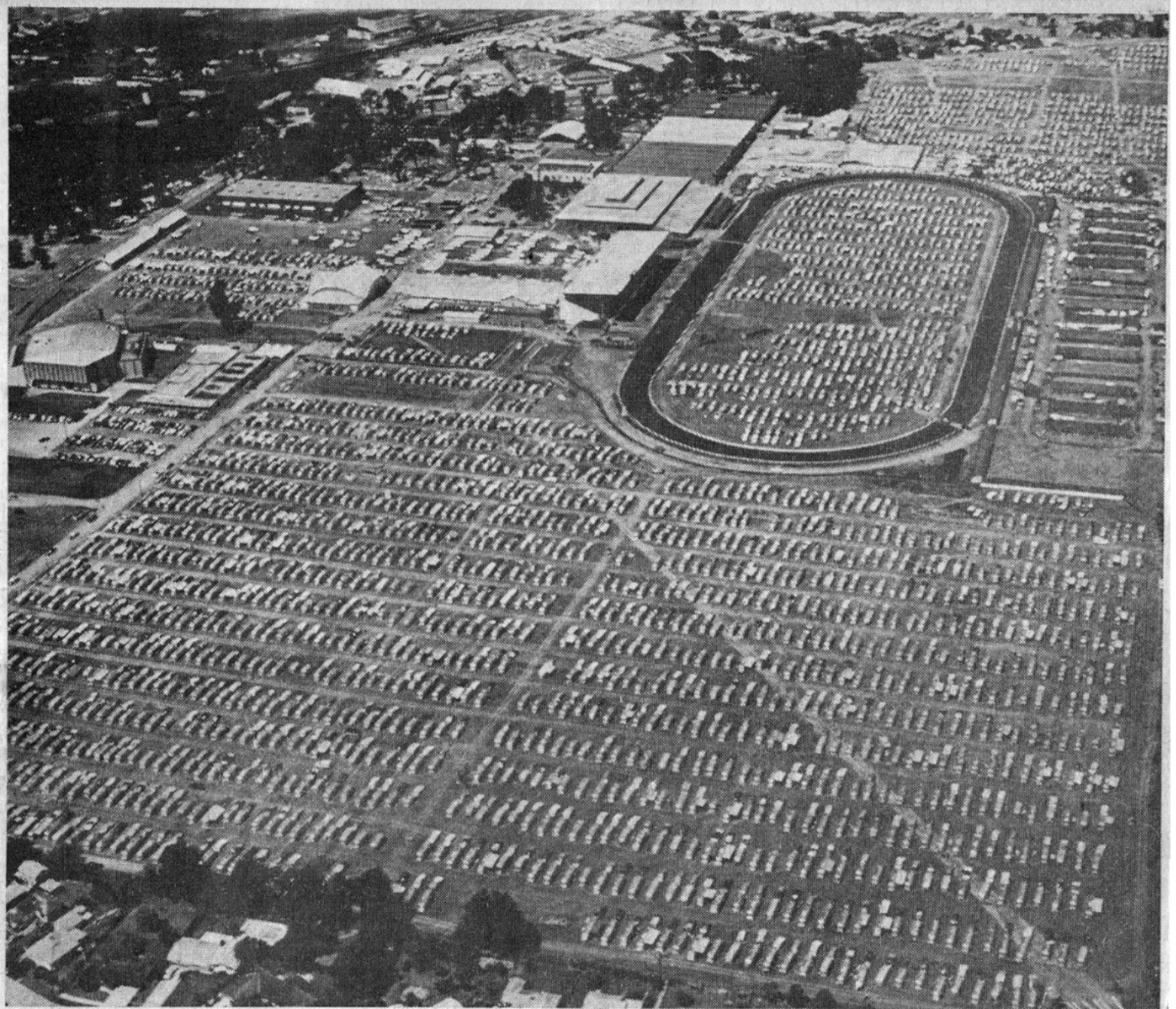

Mr. and Mrs. Kolhoff, Lockwood and Rivkind were installed as new members.


The anniversary and birthday announcements were made by President Raboin.



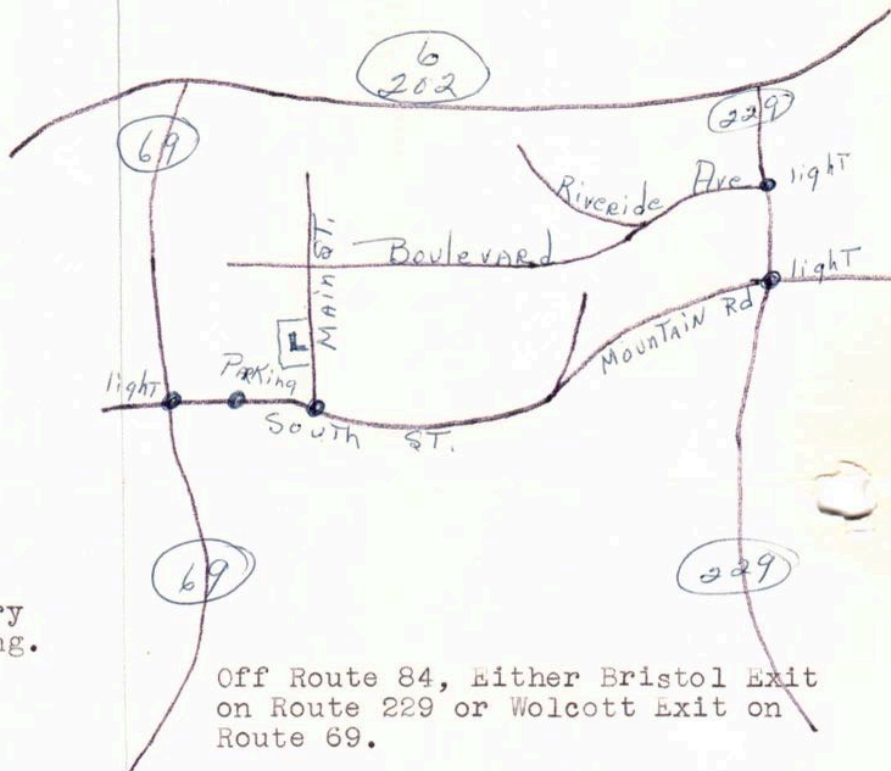

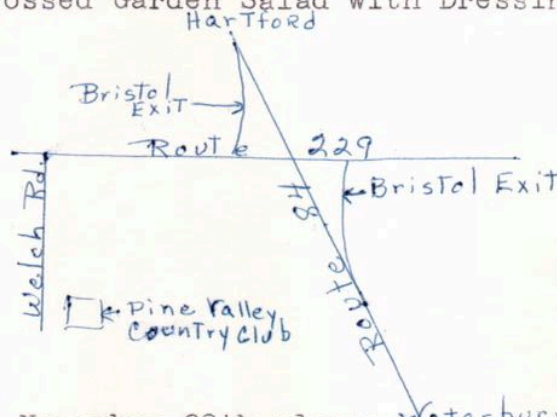
