- April 11, 2024. The complete updated Rally Planner by the Constitution and Bylaws Committee was submitted to the NorCal board for review and final approval. Approved on 4/13/2024 by a unanimous e-vote and will be posted to the NorCal Website."
- Region 12 Business Meeting. In order to facilitate more communication, Carmen Ortiz will propose quarterly Region 12 business meetings on Zoom to keep our local clubs more involved at the regional level.
- 2024 International Flag Bearer will be affiliate member Ken Bechtold.
- Incidents involving aggressive dogs. A member of NorCal attended a rally with another club to which he brought three large, aggressive dogs. One of his dogs was involved in an incident that resulted in injuries and medical costs for another camper's dog. When our member delayed paying the bill, the campground notified the other club about the incident, and banned him from the campground in the future. The president of NorCal was contacted and briefed on the situation. There are procedures in place at the international club level to deal with these types of grievances. Per those procedures, the president of the other club and the region president contacted the member and informed him that he is welcome to rallies but cannot bring his dogs. That applies to any rally within the international club, not just the clubs involved. They also obtained his commitment to pay the other pet's medical bill. The international club and many local clubs have pet policies in place, NorCal does not. President Ortiz asked John Bibby, chair of the constitution and bylaws (CBL) committee, to draft a policy similar to what already exists at the international level to be included in our bylaws. Such policy would guide members attending rallies with their pets and help avoid issues in the future. The CBL will submit the draft policy to the executive board for concurrence. The policy will be included in rally announcements as a reminder to members bringing their pets. Members will also be reminded to check the campground's pet policy before attending a rally.
