If you are at the RV park before the 23rd or after the 26th, activities are self-organized.

Friday (May 23)

- **6pm - Hop Dogma Brewery and Food Trucks**
 - Walk a short 100ft from the campground entrance to Hop Dogma's taproom.
 - At least one on-site rotating food option and there are one or more food trucks in the adjacent parking lot.
 - Food is allowed to be brought into the taproom.
- **Dusk - Campfires in the RV park.** Look for the propane fire pits glowing in our area of the park. Bring yours over to add to the glow or just bring a drink, a chair, and hang out.

Saturday (May 24)

- **Morning - Activities on your own.** See the list below for ideas. Search Google / Yelp / Trip Advisor or your favorite website/app for things to do.
- **3pm - Jettywave Distillery**
 - 10 minute walk from the RV park (parking very limited)
 - We'll be hanging out here for the afternoon and through dinnertime.
 - **If you signed up for the tour, please be prompt at 3pm. Our tour starts then.**
 - There are spirits, wine, and beer available on-site.
 - The food is also excellent here, reasonably priced, and covers most dietary needs.
- **7pm - Old Princeton Landing Public House and Grill**
 - Local entertainment venue. Not necessarily excellent in Grapes and Grains fare. Included as information only. Bar food and drinks are available.
 - 2 minute walk from Jettywave, 5 minute walk from the RV park
 - Varying music acts. Tickets may be required depending on the talent. Check their website for details in the weeks beforehand.
- **Dusk - Campfires in the RV park.**

Sunday (May 25)

- **9am - Brunch drinks at the RV park**
 - pre-registration required or bring \$5 cash
 - Supplies for mimosas, bloody marys, and bellinis will be provided.
 - Bring a glass and enjoy a drink of your choice.
- **noon - Blue Ocean Brewing**
 - **If you signed up for the tour, please be prompt at noon. Our tour starts then.**
 - Rotating food catering on-site
 - Sometimes a music act
- **2pm - Trojak-Knier and Barterra wineries** (both in the same building)
 - 6 minute walk from Blue Ocean or 17 minutes from the RV park
 - TK closes at 4:30pm, Barterra at 6pm

- Tasting fees vary between the two
- **Dinner on your own**
- **Dusk - Campfires in the RV park.**

Monday (May 26)

- **8am - Goodbye continental breakfast**
 - Bagels, pastries, muffins, and donuts
 - Enjoy your morning coffee with those hanging around or, if you need to split early, just grab & go.

Things to do in the area

1. Search Google Maps for brewery/winery/distillery
2. Drive CA-1 (Pacific Coast Highway) in either direction
3. Visit San Francisco (about 45 minutes one-way depending on traffic)
4. Within walking distance of the RV park
 - a. Charter fishing
 - b. Shore/pier fishing
 - c. Paddle sports (kayak, paddleboard, etc.), rentals
 - d. Many many many good restaurants
 - e. Two fresh seafood markets
 - f. General shopping
5. Saturday morning farmers market (225 CA-1, Half Moon Bay)

These events will include visiting wineries, breweries, brew pubs, and distilleries, which may require visitors to be of legal drinking age (21 years of age or older). Grapes & Grains reserves the right to not allow anyone under the age of 21 to participate in any or all activities at a Grapes & Grains event.

Grapes & Grains Refund Policy

Members who cancel after being registered for any event will forfeit any third-party non-refundable fees incurred by Grapes & Grains (G&G) or the event sponsor including but not limited to reservation fees, processing fees, site cancellation fees, prepaid excursion, tour, entertainment, and event fees. Any member/registrant who cancels within 30 days of the rally start date will forfeit any prepaid rally fees and depending on the venue, potential RV site fees. Regardless of the reason or cause, if the timeliness of cancellation of your attendance does not allow G&G or it's host(s) to find replacement attendees or obtain refunds from any of the vendors or providers, a refund will not be made, and forfeiture of those costs will be incurred by the canceling member.

If G&G should cancel a rally or event, all fees paid by any member/registrant will be refunded.

This G&G refund policy is premised on the concept that the intra-club should neither profit from nor subsidize the cost of any member or registrant who cancels after registering for a G&G sponsored or hosted rally or event. We understand that circumstances arise where a cancellation may be necessary, and every effort will be made to minimize the financial impact on both the intra-club and the member/registrant.

Any member/registrant who does not agree with a refund decision made by the organizers of a G&G-sponsored event may appeal that decision to the G&G Executive Board by filing a written appeal request, including the reasons for a reversal of the refund decision, within 30 days of the original refund decision.
