**Previous Meeting Minutes** were read by Charlene Nelson Motion to accept by Rick Keith, 2nd by Steve Mathias All members approved by vote.

- Ending balance \$2,081.78

Ed confirmed that Region 8 is committing \$250. He has suggested each club provide an additional \$125. A member expressed concern that these costs be reviewed at Business meetings before approval.

#### **New Business and Discussion:**

- Discussion of changing the Units fiscal year to match ACI's fiscal year was moved and approved in the executive meeting. The new year will be January 1 December 31.
- By-Laws and Constitution are required to be reviewed every 5 years. Jane will be providing a template for members to review. This will be shared with the next newsletter.
- Members are to review the by-laws and constitution and prepare any suggested changes. All suggested changes should be sent to 2025 President, Jane Mathias.
- A recommendation was made to add **Directory Manager** to the list of committees.
- For the upcoming 2026 Executive Officers Jane noted that we should consistently use the term "unit", or "club" in all official records.
- Jane shared that if we don't have a rally scheduled, a newsletter does not go out. She recommends that a Facebook page be created for the club, people can reference activity there. It was shared at the York IR that this is being done by other clubs.
- Colette Krupko described the Webmaster role, she puts all updates on the ACI website by the 1<sup>st</sup> of the year. This includes documents and rallies as they are announced.
- Jill O'Connor shared that as Membership chair she will be creating a region calendar that will share rallies of all units in our Region. This will be in PDF format by end of the 2025.
- Charles recently cleaned up the format of the directory, by-laws, and constitution. All
  information is from the ACI database, but members should review for accuracy. Large
  formats are available. (Note: Jim Foster is listed but passed this year.)
- Bryan Nelson shared a brief overview of Harvest Host, it's structure, and advantages.
- Steve Mathias shared examples of potential club logo, flag, and patch designs that we
  could use. He is looking for other ideas and encourages you to share. Rick offered to
  shared past examples. Currently the club does not have a dedicated flag.
- Jane would like to think ahead for 2026 rallies now so we have time to plan ahead. She and Steve will do a rolling rally. Other ideas include pop-up lunches.
- Jane shared a list of individuals qualified for stars.
- The topic of attracting new members was raised, current members are asked to think of ways to attract others. Please reach out to other members if they live close to you.
- Jane also thanked Charles for his work on the directory, Colette for being our parliamentarian mentor and managing the website, Marsha for her work as treasure, Rick for outgoing trustee, and Ed and Jill for all their support.
- Jane shared a calendar of upcoming rally dates and a map showing where current members live. John Baker proposed Will Hollow in AR as a potential site.
